AREA, TYPE LAND AND LOCATION:  
A 1.147 acre parcel of tide and submerged  
land in the bed of the Sacramento River,  
approximately 8 miles south of I-80 crossing,  
Sacramento County.

LAND USE: Continued operation and maintenance of  
an existing marina.

TERMS OF ORIGINAL LEASE:  
Initial period: 5 years from August 7,  
1978.  
Renewal option: 1 successive period of  
5 years.  
Surety bond: \$2,000.  
Public liability insurance: \$100,000/300,000  
per occurrence for bodily  
injury and \$50,000 for  
property damage.  
Consideration: \$706.55 per annum.

TERMS OF PROPOSED ASSIGNMENT:  
Initial period: 5 years from August 7,  
1978.  
Renewal option: 1 successive period of  
5 years.  
Surety bond: \$2,000.

**BASIS FOR CONSIDERATION:**

8% of appraised value of land.

**PREREQUISITE TERMS, FEES AND EXPENSES:**

Applicant is permittee of upland.

Processing costs have been received.

**STATUTORY AND OTHER REFERENCES:**

A. P.R.C.: Div. 6, Parts 1 & 2.

B. Cal. Adm. Code: Title 2, Div. 3.

**OTHER PERTINENT INFORMATION:**

1. An EIR is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907, Class 1(B), which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation.

2. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

A rectangular parcel of tide and submerged land, 714 feet long and 110 feet wide, in the Sacramento River, Sacramento County, California described as follows:

The southerly line of said parcel being parallel with and 10 feet southerly of the most southerly edge of an existing floating dock, the easterly line of said parcel being 10 feet easterly of the most easterly edge of said dock, said dock being adjacent to that land described in that deed recorded February 9, 1951, in Volume 1990 at page 111, Official Records of Sacramento County.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark of the Sacramento River.
