A 0.104 acre parcel of submerged lands

LAND USE: Maintenance of an existing pier and two-story
structure utilized as sleeping quarters
on the upper floor, with boat storage below.

TERMS OF EXISTING LEASE:
Initial period: 15 years from July 2,
1969.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

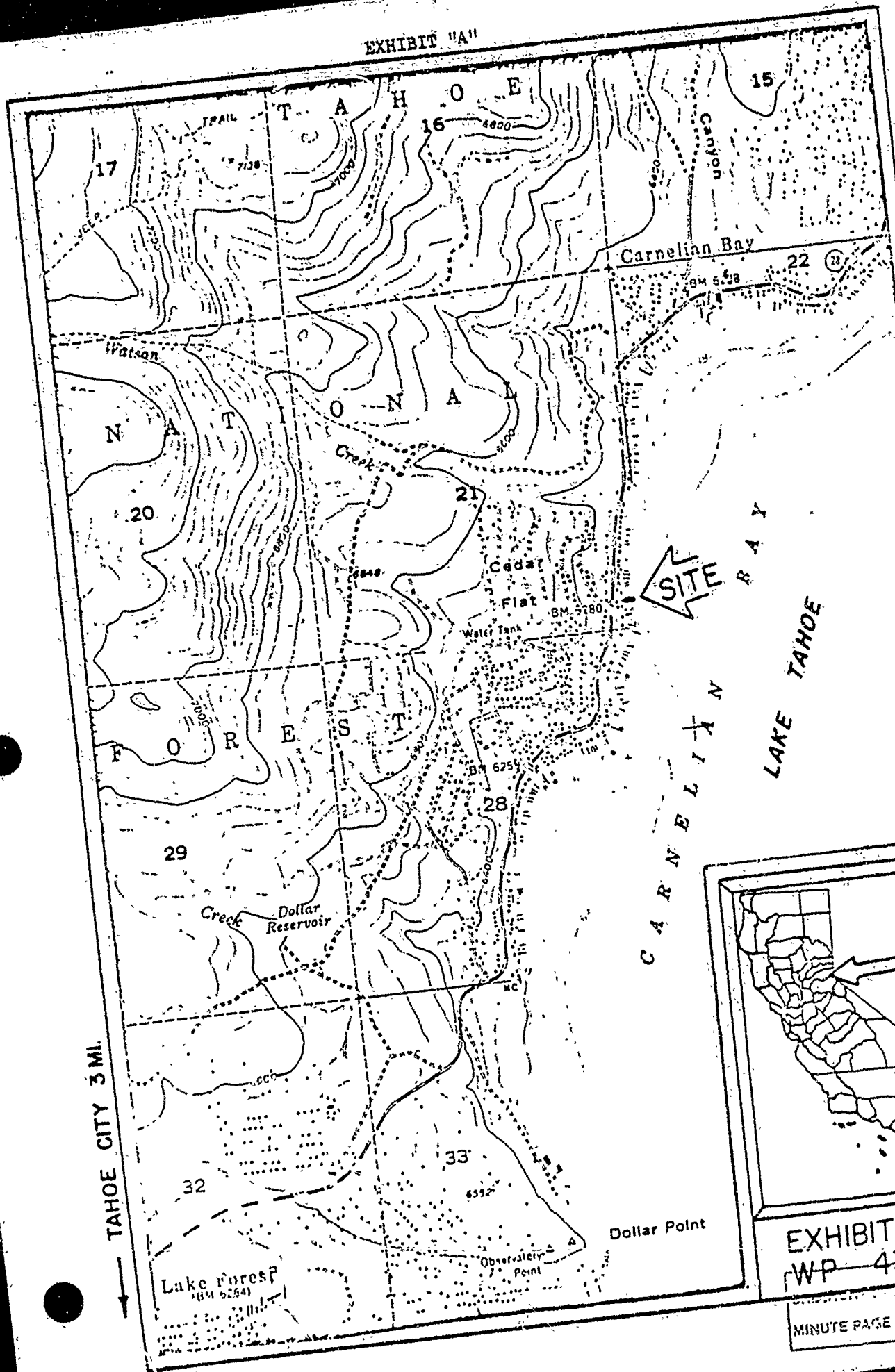

LAKE TAHOE

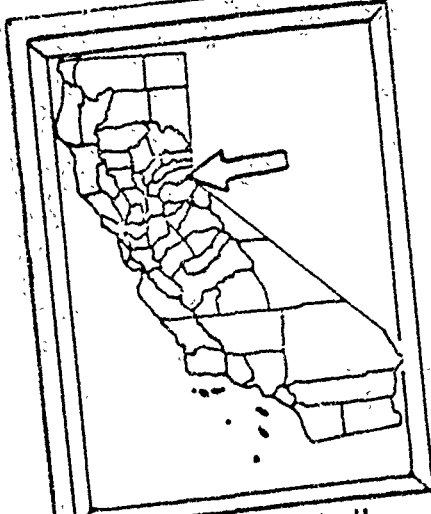
