PREREQUISITE ITEMS:

Compliance by lessee with terms and conditions of lease through August 29, 1977 (date of termination of lease), including payment in advance of annual rental of \$1,200.00. Leased area was relinquished in its original condition.

PROPOSED ACTION:

State Oil and Gas Lease PRC 4801.1, containing 240 acres of proprietary lands in the City of Sacramento, was issued August 30, 1973, to Atlantic Oil Company. The lease contained a three year drilling requirement, which was extended by the Commission for a one-year period through August 29, 1977 Atlantic never drilled a well on the leased area and, in accordance with Section I of the PRC 4801.1, the lease automatically terminated on August 29, 1977. In order to maintain a clear record of title to the leased lands, the Lessee filed a quitclaim deed for acceptance by the State.
