AUTHORIZATION TO EXECUTE AND
DELIVER A QUITCLAIM DEED

The Commission staff has recently been contacted by the National Park Service concerning their plans to construct an Administrative Headquarters for the Channel Islands National Monument in Ventura. The area where this Headquarters is to be built is in the general location of a possible claim of title by the State. Under the United States Land and Natural Resources Division Directive No. 10-68, regarding acceptability of defeasible fee titles under 40 U.S.C. 225, the United States Attorney advises that structures may not be built on areas subject to State titles. The Commission staff has reviewed the construction site in question and finds that the State Lands Commission has no claim of title on this specific parcel. The site in question, containing 2.8 acres, is to be a major component in the Channel Islands National Monument. The title resolution is of extreme urgency to allow the timely construction of the facilities involved.

On the basis of the extreme urgency of the matter and the overall public benefit to be derived from this facility, the staff proposes that the title to the physical site needed for the Administrative Headquarters be cleared of any possible State claim by delivery of the State's quitclaim deed. This is proposed eventhough the staff feels the State has no title within the parcel.

Although the staff recommends the resolution of the problem at hand in the manner described above, it is recommended also that the record reflect that this agreement shall only apply to the land in question and shall not constitute any expression by the Commission as to boundaries or the character of title to any other lands not subject to this agreement.




