TERMS OF PROPOSED LEASE:

10 years from une 1, 1979. Initial perrod:

Public liability insurance: Combined single

limit coverage of \$100,000 per occurrence, for bodily injury and property damage.

CONSIDERATION:

\$225 per annum, with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is owner of upland.

Filing fee has been received.

STATUTORY AND OTHER REFERENCES:

P.R.C.: Div. 6, Parts 1 & 2.

Cal. Adm. Code: Title 2, Div. 3.

OTHER PERTINENT INFORMATION:

The proposed lease area consists of State-owned lakebed in GooseLake within the NW2 of Section 23, T48N, R14E, MDM. The lineal frontage along the shore is approximately 2,800 feet. The location of the State's boundary within this area has not been determined at this time.

- 2. The proposed lease area has been used by the applicant's predecessors, for livestock grazing. In 1972, Mr. Howard Welles, lessee of the applicant's predecessor (Lumberman's Acceptance Company), started an adverse possession suit against Lumberman's for the proposed lease area. This has been challenged by Lumberman's Acceptance Company.
- The applicant has been advised of the current high-low water litigation regarding the State's ownership boundary within navig ble lakes such as Goose Lake, and as neverless requested a non-prejudical lease for the subject property from the State since the applicant feels that they had acquired prior rights to the property from their predecessors.
- 4. The annual rental is based upon the minimum commercial rate, which in this case is for livestock grazing, for use of the State-owned lands within Goose Lakes.
- 5. This project is exempt from CEQA because it involves the grazing of livestock where disturbance to soil does not occur.

Authority: 2 Gal. Adm. Code 2907, Class 4(A).

6. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class A, which authorizes Restricted Use.

Staff has coordinated to project with those agencies and ganizations which nominated the site s containing significant environmental values. They have found this project to be compatible with their nomination.

- 3. Bounded on the east by the west line of ints 3 and 4 of said fractional Section 23 as shown upon the U.S. Township plat of T48N, R14E, MDM dated 9/20/1872.
- 4. Bounded on the west by a line located 50 feet westerly of and parallel to the water's edge of Goose Lake.
