#### EXHIBIT "A"

A parcel of tide and submerged land in Napa County, California, lying in the bed of the Napa River, more particularly described as follows:

COMMENCING at a hub set by D. E. Ryah, Land Surveyor #2452, caid. point being in the center line of a 30-foot road right of way said point having coordinates of Y=657,436.25 and X=1,489,163.05, thence along said center line S Ol° O5' 23" W, 595.7 feet, to the south property line of that certain parcel described in Deed recorded May 1, 1913, Vol. 6, Page 282, in the Office of the County Recorder of said County from William H. Brook to Standard Oil Company of California; thence along said southerly property line N 88° 541 37" W, 256.0 feet more or less, to the TRUE POINT OF BEGINNING said point being in the Nape River and on a line which is parallel with and 10 feet waterward of new bulkhead, said bulkhead having bearing N 24° 43' 24" E, and being shown on attached Exhibit "Al" which is by this reference made a part of this description; thence N 24° 43' 24" E, 422 feet; thence S 65° 16' 36" E to the ordinary high water mark along the east bank of said Napa River; thence southerly along said ordinary high water mark to the abovementioned south property line of Standard Oil property hereinbefore described; thence N 88° 54' 37" W along said south property line to the true point of beginning.

This description is based on the California Coordinate System Zone 3.


