ACCEPTANCE OF A QUITCLAIM DEED AND
TERMINATION OF COMMERCIAL LEASE

BACKGROUND: On May 24, 1960, (Minute Item No. 12) the Commission approved Commercial Lease PRC 2589.1, dated October 20, 1960, to Malibu Pier Corporation for the operation of a sport fishing pier. The lease covered a 6.1 acre parcel of tide and submerged land in the Pacific Ocean in the City of Malibu, Los Angeles County, and was for a term of 15 years, beginning November 16, 1959. Consideration was \$1,324.00 per annum. Lease PRC 2589.1 dated October 20, 1960, expired November 15, 1974, and has since been in holdover status.

CURRENT SITUATION:

A Quitclaim Deed for Lease PRC 2589.1 dated October 20, 1960, has been executed by the Lessee. The Quitclaim Deed is to be effective upon the close of escrow of the sale of the pier from Malibu Pier Corporation to the Department of General Services.

LAND DESCRIPTION

AN AREA OF TIDE AND SUBMERGED LAND LYING BETWEEN A LINE EXTENDING INTO THE PACIFIC OCEAN BEARING S. 24° 50' 30" E., SAID LINE BEING S. 24° 50' 30" E. 40 FEET AND N. 65° 09' 30" E. 81.50 FEET FROM ENGINEERS CENTERLINE STATION 947 PLUS 68.93 AT THE WESTERLY EXTREMITY OF THAT CERTAIN CENTERLINE COURSE DESCRIBED IN DEED FROM T. R. CADWALADER, ET AL. TO THE STATE OF CALIFORNIA RECORDED IN BOOK 15228, PAGE 342, OFFICIAL RECORDS OF LOS ANGELES COUNTY AND A LINE EXTENDING INTO THE PACIFIC OCEAN BEARING S. 30° 36' 30" E., SAID LINE BEING S. 24° 50' 30" E. 40 FEET AND SOUTHWESTERLY ALONG THE ARC OF A CURVE 318.42 FEET, SAID CURVE BEING CONCAVE SOUTHEASTERLY WITH A RADIUS OF 1960 FEET FROM ENGINEERS CENTERLINE STATION 947 PLUS 68.93 AT THE WESTERLY EXTREMITY OF THAT CERTAIN CENTERLINE COURSE DESCRIBED IN DEED FROM T. R. CADWALADER, ET AL. TO THE STATE OF CALIFORNIA, RECORDED IN BOOK 15228, PAGE 342, OFFICIAL RECORDS OF LOS ANGELES COUNTY AND THE LINE OF THE ORDINARY HIGH WATER MARK OF THE PACIFIC OCEAN BETWEEN THE INTERSECTIONS OF THE AFOREMENTIONED LINES AND A LINE PARALLEL TO AND DISTANT 700 FEET FROM SAID ORDINARY HIGH WATER MARK, CONTAINING 6.1 ACRES MORE OR LESS.

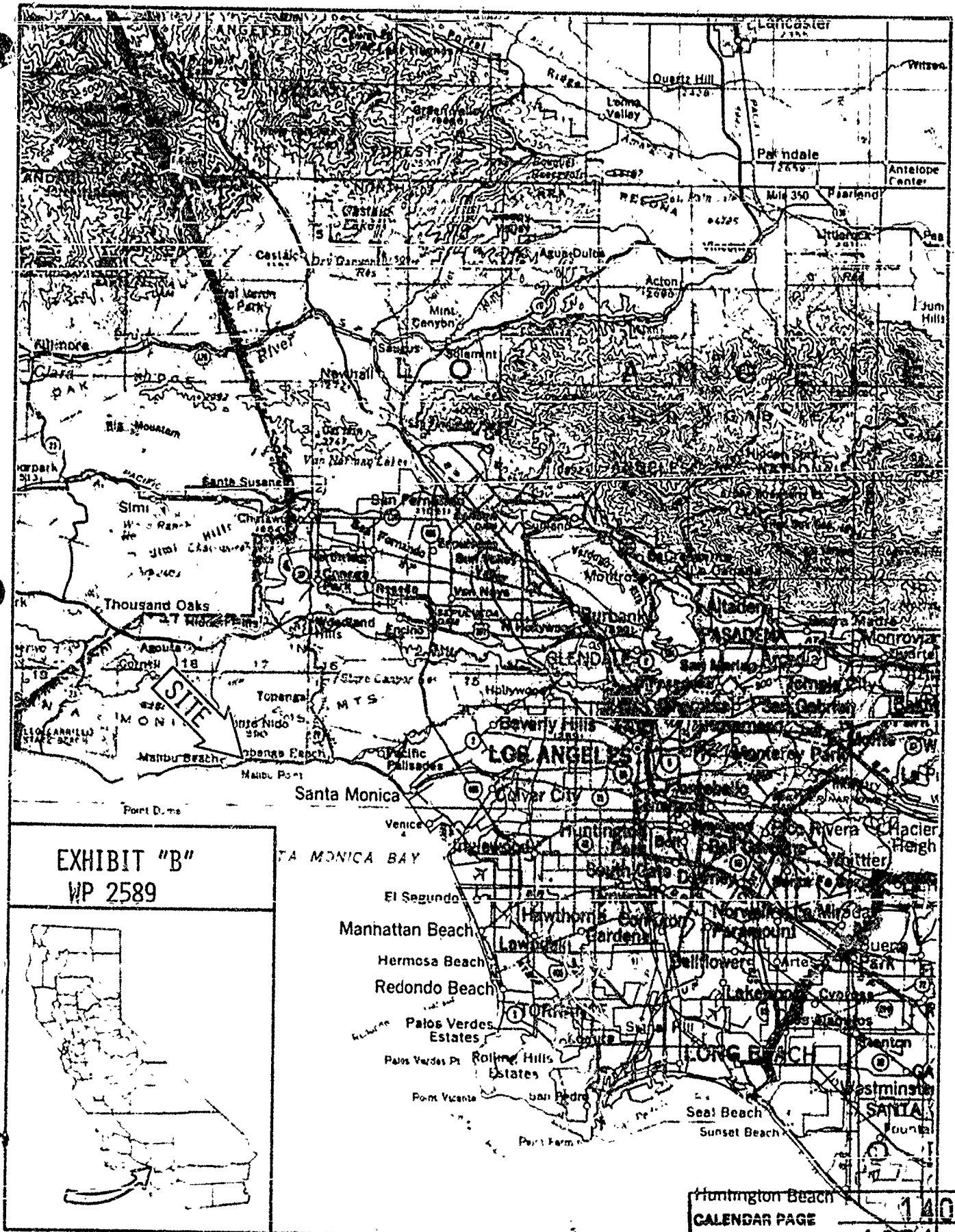
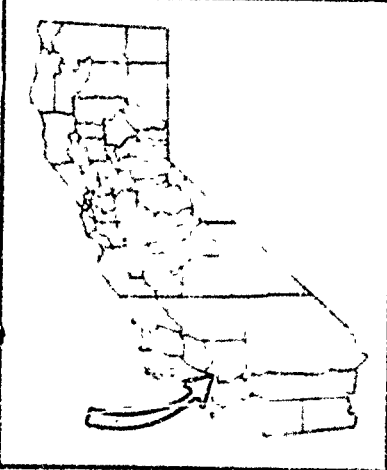
