#### PROPOSED RATIFICATION OF DISCLAIMER

The land described in Exhibit "A" below had been a part of those lands subject to the suit entitled State of California, ex. rel. State Lands Commission v. United States of America, et. al., United States District Court for the Northern District of California, Civil No. C-79-1865 WTS. Fursuant to oral authority provided by the Chief Counsel of the State Lands Commission, who had polled and gotten the consent of two Commissioners, the Office of the Attorney General disclaimed on behalf of the State Lands Commission any interest in the land described in Exhibit "A". The complaint in State of California etc. v. United States, et. al., was amended to reflect the Disclaimer. The areas disclaimed were lands at issue in other cordemnation and quiet title actions to which the State of California, State Lands Commission, was a party and is bound by court or stipulated judgments. By those judgments, the State Lands Commission no longer has an interest in the property which was disclaimed.

The Office of the Attorney General requests the State Lands Commission to ratify the disclaimer which has already been made.
