AUTHORIZE EXECUTION OF A SUPPLEMENTARY LETTER OF UNDERSTANDING

BACKGROUND:

At its meeting on March 28, 1979, the Commission approved a General Lease - Commercial Use, for reconstruction and continues maintenance of an existing marine complex including floating docks, walkways and boat hoist to Jack Arbuckle dba Courtland Docks. The lease provides for an annual rental of \$418.40 with a start date of September 1, 1977.

On April 15, 1981 Commission staff advised the lessee that he was four years in arrears on rental payments, insurance certificate had expired and the required surety bond had never been received.

CURRENT SITUATION:

Lessee, to date, has submitted a certificate of insurance and three back rental payments.

The rental for the years 1980 thru 1981 and 1981 thru 1982, together with penalty and interest, is due and payable at this time. Inasmuch as the lessee is cooperating with staff and that the primary income producing season is about to end, staff recommends that a supplementary Letter of Understanding be prepared which provides that:

"Notwithstanding Paragraph 2 of Section 5 of PRC 4051.1, which provides in part that lessee agrees to pay the annual rental to hessor without deduction, delay or offset; Lessee shall pay lessor the sum of \$836.80 in ten equal monthly payments of \$83-68 commencing on September 8, 1981 with the final payment due and payable on June 8, 1982. Upon r. ceipt of the June 8, 1982 payment staff will bill the lessee for the penalty and interests due on the late payments of annual rental."



UPON RECEIPT OF THE JUNE 8, 1982 PAYMENT STAFF WILL BILL THE LESSEE FOR THE PENALTY AND INTEREST DUE ON THE LATE PAYMENTS OF ANNUAL RENTAL.
