- 2. An EIR is not required. This transaction is within the purview of 14 Cal. Adm. Code 15103, Class 3(d), which exempts new construction of small structures.
- 3. This project is situated on State land identified as possessing significant environmental values pursuant to F.R. 6370., and is classified in a use category Class B, which authorizes Limited Use.

Staff has coordinated this project with those agencies and organizations which nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.

APPROVALS REQUIRED AND OBTAINED:


