TERMS OF PROPOSED LEASE: 5 4

Initial period:

Ten years from May 15. 1981.

Special:

1. The number of animals permitted on the leased land is restricted to those that can be supported by the available forage and water, taking into consideration forage and water reserved for necessary wildlife use. The available carrying capacity is estimated to average 61 animal unit months annually However, the actual capacity may wary over the term of this lease die to climatic conditions or other natural phenomena.

Lessee shall take all reasonable and necessary actions to prevent, suppress _nd Control fires

In good repair the fencing on a portion of the north boundary and along the east boundary of the leased premises.

CONSIDERATION:

\$141 per annum with the State reserving the right to fix a different rental on the fifth anniversary of the lease.

BASIS FOR CONSIDERATION:

Pursuant to 2 Cal. Adm. Code 2005(b) (4). The estimated carrying capacity of the 615 acres is 61 animal unit months; at the rate of \$2.31 per animal unit months; the rental is \$141 per annum.

Filing fee and the first year's annual rental have been received.
