The State Lands Commission is a party to United States condemnation actions brought by the United States Attorney entitled United States of America v. 1.56 Acres of Land, More or Less, et al., United States of America v. 2.51 Acres of Land, More or Less, et al., United States of America v. 0.87 Acres of Land, More or Less, et al., United States of America v. 0.14 Acres of Land, More or Less, et al., filed in the United States District Court, Eastern District of California, Civil Nos. CIVS-81-485, CIVS-81-481, CIVS-81-478, CIVS-81-482, involving land in Trinity County to be used in connection with an access road to administer public lands to extinguish fires, and to provide the public access. The condemnations are for a perpetual easement.

Upon examination of the Commission's records pertinent to the area, it has been ascertained that there is no interest held by the State Lands Commission as to the tracts of land described in the notices of condemnation.

Inasmuch as these suits involve land over which the Commission has no jurisdiction, it is recommended that a disclaimer be filed on behalf of the State Lands Commission disclaiming any compensable right, title, of interest in the tracts of the subject condemnation.

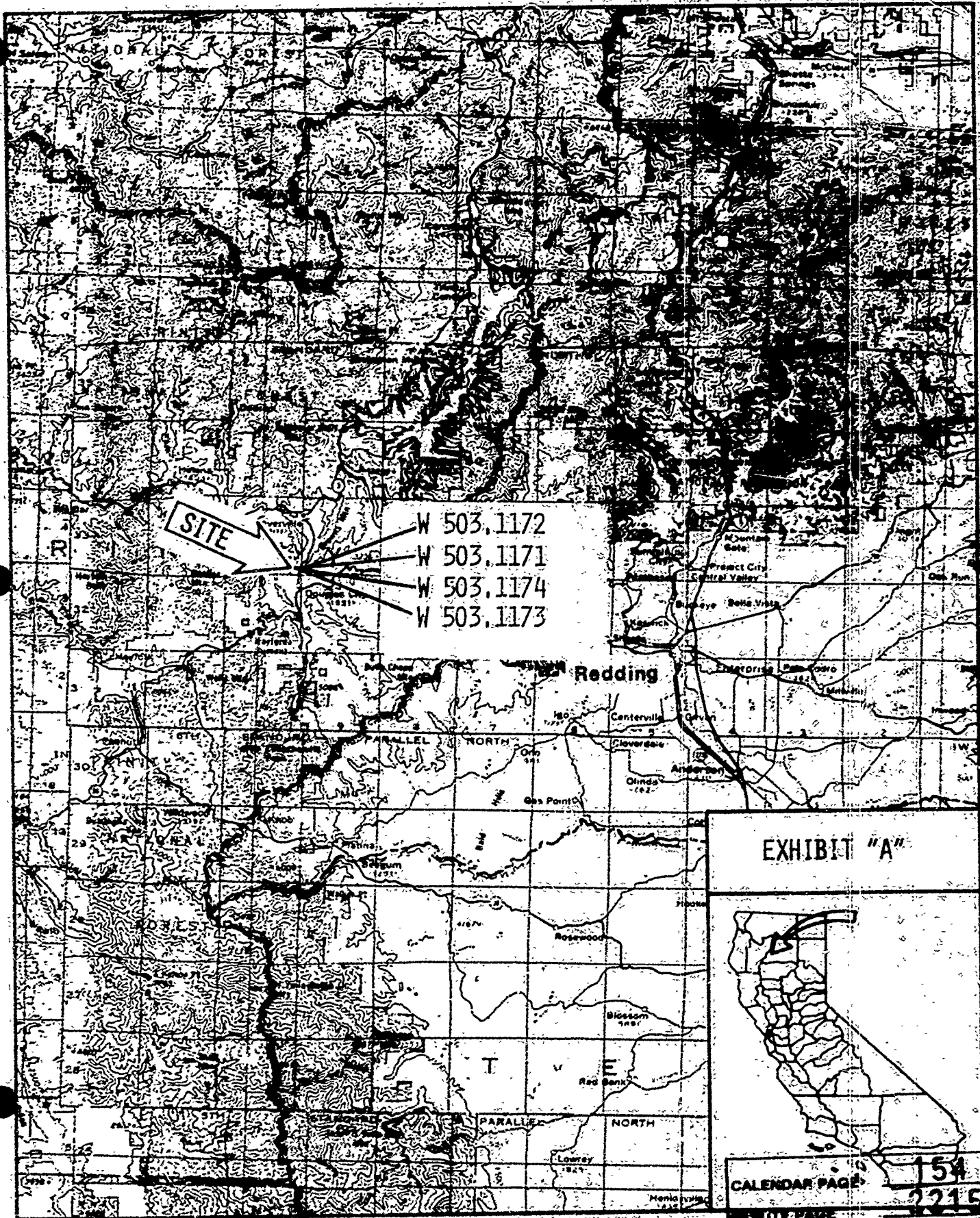
