## OTHER PERTINENT INFORMATION:

- 1. The annual rental value of the site is estimated to be \$100.
- An EIR is not required. This transaction is within the purview of 14 Cal. Adm. Code 15103, Class 3(d), which exempts new construction of small structures.
- 3. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category "Class B", which authorizes Limited Use. The project as proposed will not have a significant effect upon the identified environmental values.
