AUTHORIZATION FOR PREPARATION
AND PROCESSING OF A STATE PATENT
TO BE ISSUED TO C. M. DOWLING

Mt. Shasta Title and Escrow Company has requested that a State patent be issued for 40 acres, more or less, of State school lands in Siskiyou County as described in Exhibit "A". An application for purchase of the parcel (No. 4785 Shasta Land District) was filed by C. M. Dowling with the Surveyor General on August 26, 1907 and a Certificate of Purchase No. 5580, showing payment made in full, was issued on April 17, 1908. The original certificate of purchase is in the files of the Commission and no patent has yet been issued to complete the chain of title on the parcel.

Staff and the Office of the Attorney General have examined the file and other information submitted by Mt. Shasta Title and have concluded that the laws relating to issuance of a patent for the above described lands have been complied with, and that the person to be named in the patent (C. M. Dowling) is entitled to it.

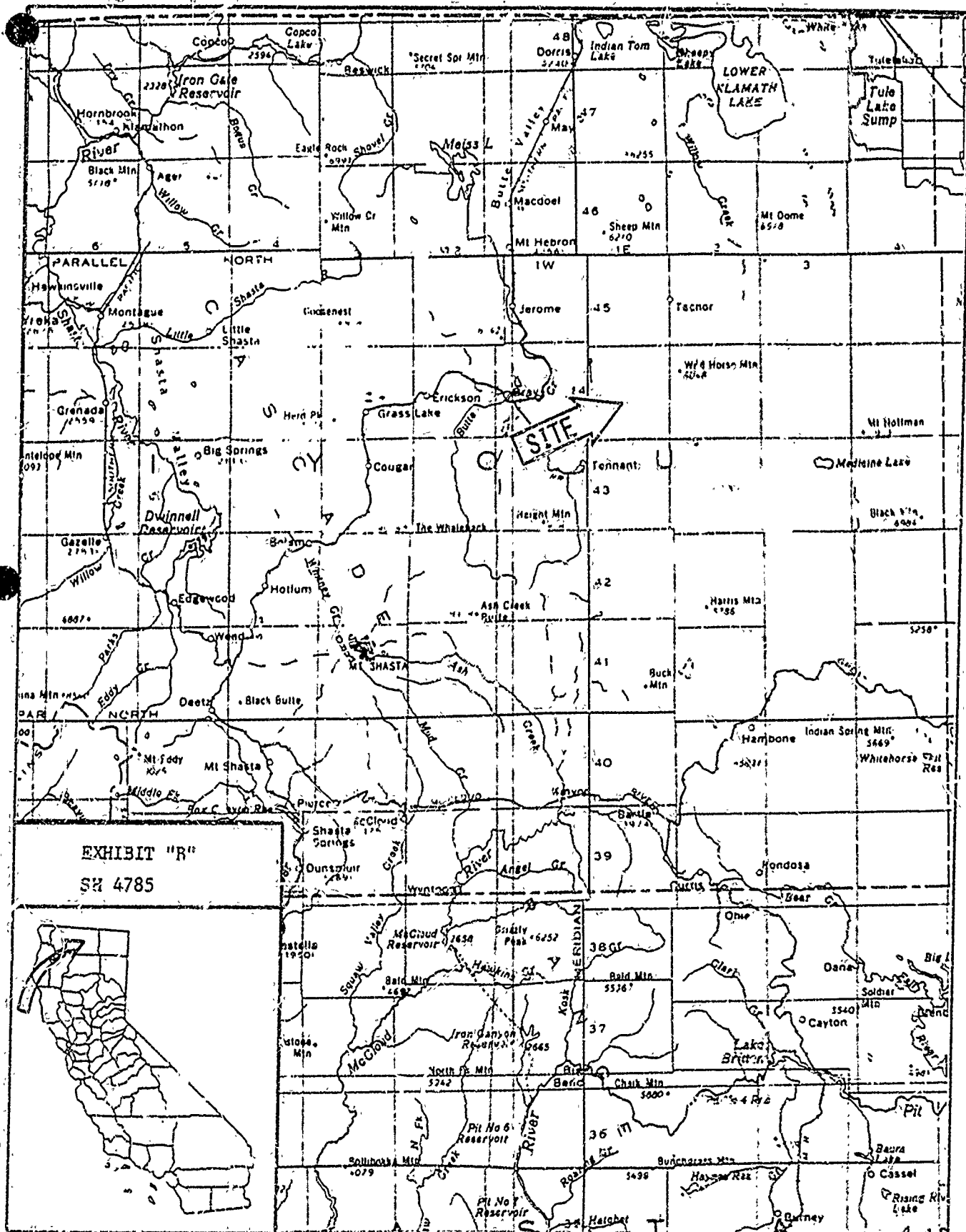
