AMENDMENT OF A
GENERAL PERMIT - PUBLIC AGENCY USE

AREA, TYPE LAND AND LOCATION:
A 0.344-acre parcel of submerged land in
the Sacramento River located at Pittsburg,
Contra Costa County.

LAND USE: Public fishing pier.

TERMS OF ORIGINAL PERMIT:
Initial period: 15 years from May 1, 1975.

CONSIDERATION: The public use and benefit.

BASIS FOR CONSIDERATION:
Pursuant to 2 Cal. Adm. Code 2003.

PREREQUISITE TERMS:
Applicant is lessee of upland.

OTHER PERTINENT INFORMATION:

1. Applicant has requested the permit area to be increased in order to encompass an additional public fishing platform.
2. The area needed for this amendment is currently under lease to Pacific Gas and Electric Company. Pacific Gas and Electric Company has consented to the project. The annual rental value of the site is estimated to be \$500.
3. This project is exempt from CEQA because it is new construction of a small structure.

Authority: 14 Cal. Adm. Code 15103.

4. The project is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1 and is classified in a use category "B" which authorizes Limited Use.

LAND DESCRIPTION

WP 5011

A parcel of tide and submerged land lying in the bed of the Sacramento River adjacent to the left bank and in the vicinity of the City of Pittsburg, Contra Costa County, State of California, said parcel being more particularly described as follows:

COMMENCING at Station No. 6 of the Boundary Line Agreement between the State of California and Pacific Gas & Electric Company recorded September 20, 1962, in Book 4206 O.R. Page 55, records of said county and as shown on the map entitled "Plat of the North Property Line of P.G.&E.", recorded in Book 19 of Licensed Surveys, Page 33; thence along said boundary line N 72° 21' 01" 663.78 feet to Station No. 5; thence continuing along said boundary line N 88° 52' 32" W 322.00 feet to the TRUE POINT OF BEGINNING; thence leaving said boundary line and into the Sacramento River N 01° 07' 28" E 200.00 feet; thence N 88° 52' 32" W 75.00 feet; thence S 01° 07' 28" W 200.00 feet to the aforementioned boundary line; thence along said boundary line S 88° 52' 32" E 75.00 feet to the true point of beginning.

The bearings used in this description are based on the California Coordinate System, Zone 3.

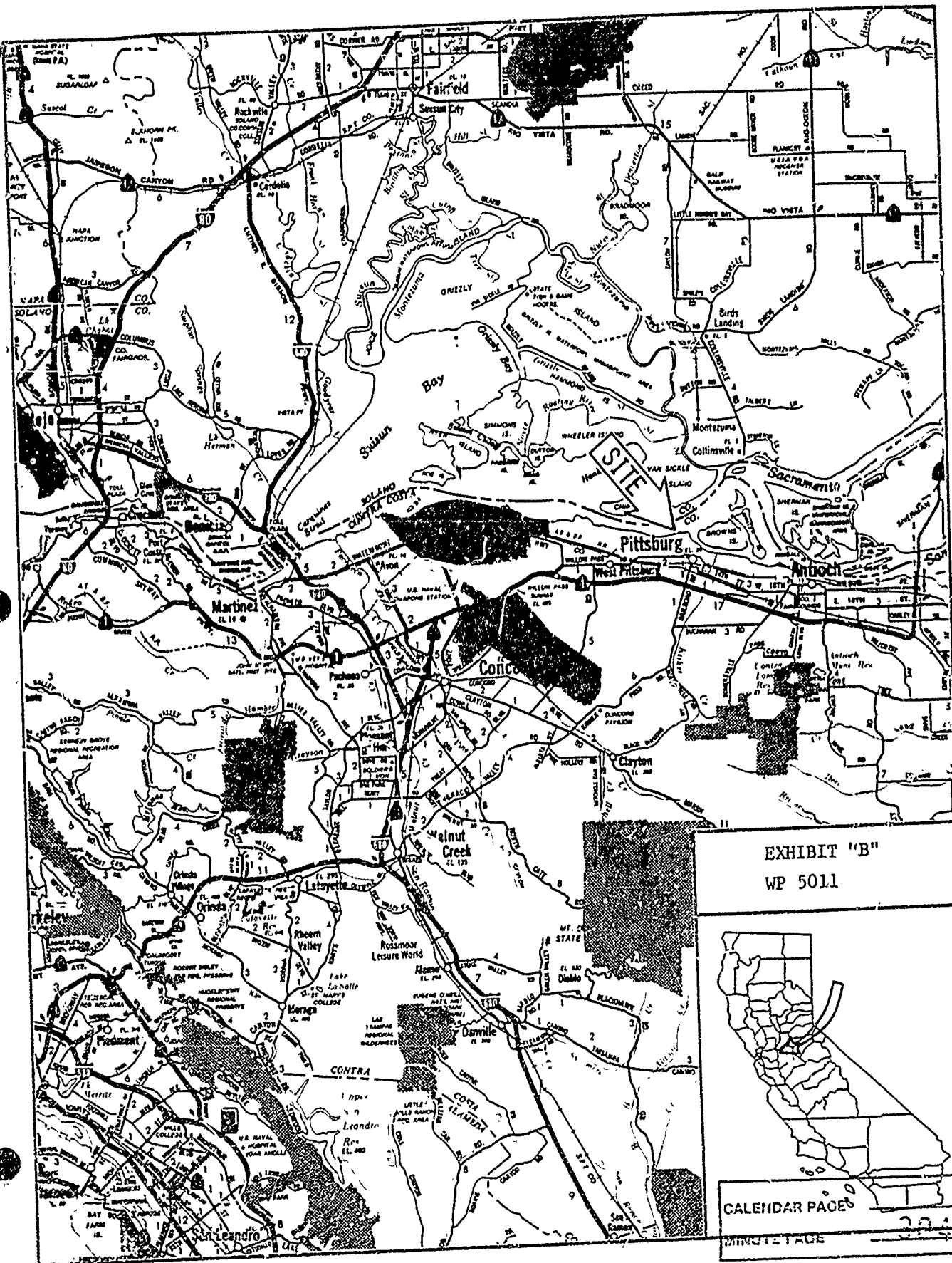
