AMENDMENT OF OIL AND GAS LEASE

AREA, TYPE LAND AND LOCATION:

182 acres in the bed of the Sacramento River near Princeton in Glenn and Colusa Counties.

PERTINENT INFORMATION;

State Oil and Gas Lease PRC 6206.1 was issued to Jordan Oil and Gas on August 26, 1982. Un September 1, 1982, Jordan reported to Commission staff that there appeared to be an error in the land description used in the lease, specifically that incorrect coordinates had been used in the description. Staff reviewed the lease and determined that a revision of the land description was necessary. The revised land description is attached as Exhibit "A". The revised description reduces the acreage under lease from 182+ acres to 131+ acres.

Pursuant to PRC Section 6507, any error in the description of any lease may, with the consent of the holder thereof, be corrected or any description amended by the Commission when in its judgment it is to the best interests of the state to do so. Therefore, staff proposes approval of an amendment of the lease to reflect the correct land description and acreage.
