AWARD OF ROYALTY OIL SALES CONTRACT

On October 28, 1982, the Commission authorized the competitive bid sale of royalty oil produced from State Oil and Gas Lease PRC 3120. Currently the State is receiving payment for the oil from the lessees (Atlantic Richfield Company and Mobil Oil Corp.). The State's share of royalty oil produced from State Lease PRC 3120 is approximately 1700 barrels per day with an average gravity of 20.2° API.

On November 1, 1982, the royalty oil from this lease was offered for sale effective July 1, 1983. Three bids were received and opened on November 16, 1982 (see Exhibit "A"). Staff has reviewed these bids for compliance with the applicable rules and regulations. The highest bidder is:

> U.S. Oil and Refining Company 5150 Wilshire Boulevard Los Angeles, California 90036

U.S. Gil has offered to pay in addition to the base price bonus of \$0.69 per barrel for 12 months commencing July 1, 1983. The base price is defined as the highest price posted for oil of like gravity and quality in the South Elwood Offshore Field. The transfer of oil from State Oil and Gas Lease PRC 3120 will be accomplished utilizing existing pipeline marine terminal facilities. Acceptance for the bid and issuance of a sales contract is exempt from CEQA as this activity does not constitute a project.
