NATURE OF BREACH:

- Lessee has failed and refused to pay minimum annual rental for the period November 9, 1981 through November 8, 1983, (two years), and/or to report annual gross income derived from lease premises as required under the lease for the period November 9, 1981 to November 8, 1982.
- 2. To date lessee owes a total of \$5,000 in back minimum annual rental and interest and an additional undetermined amount for the period November 9, 1981 to November 8, 1982.

DEMANDS:

- 1. Written demand by certified letter dated January 20, 1982; in which staff requested lessee to submit the bond and insurance required by the lease.
- 2. Staff requested by letters dated March 8, 1982, September 3, 1982, October 14, 1982 and November 16, 1982 that lessee bring rent current and report annual gross income.

CURRENT STATUS:

The Commission staff has diligently attempted to have lessee cure its default and bring its lease current, but has been unsuccessful to date.
