SALINITY AT STEINHART AQUARIUM, THREATENING THOUSANDS OF  
MARINE LIFE CREATURES THERE. THE CITY OF SAN FRANCISCO,  
UNDER URGENCY PROCEDURES, IS PREPARING TO INSTALL A NEW UNDERGROUND  
SEAWATER COLLECTING PIPE TO COLLECT A DEPENDABLE SUPPLY OF  
SALT WATER FROM THE PACIFIC OCEAN.

I HAVE ISSUED A LETTER OF ADVANCE PERMISSION TO
