OTHER PERTINENT INFORMATION:

1. Sport and commercial fisheries activities along the coastline of Ventura County are primarily centered around Ventura Marina and Channel Island Harbor. Fisheries opportunities in this near-shore area have always been limited due to a lack of rocky substrate and forests of giant kelp which normally provide habitat for important resource species. Artificial reefs have long been recognized as useful tools for increasing densities of fishes in areas of sand bottom.

In order to improve local fisheries, the Department of Fish and Game proposes to construct an artificial fishing reef in the vicinity of Channel Islands Harbor. The structure will be constructed from approximately 1,800 tons of quarried rock and will be planted with giant kelp in an effort to further enhance its fish-attracting qualities.

Long-term beneficiaries will not only include sport and commercial fishermen, but also the numerous plants, invertebrates, and fishes which find necessary habitat within the artificial reef complex.

- 2. The annual rental value of the site is estimated to be \$550.
- 3. This project is exempt from CEQA because it falls within the provisions of Title 14, Section 15104(d) (minor alteration in water and vegetation ch officially designated fish production facilities which result in greater fish production).
