OTHER PERTINENT INFORMATION:

1. The project consists of replacing an existing armored submarine cable installed in 1926 and now inoperative with an overhead power line a minimum of 30-feet above the elevation of mean high water line.

The applicant's existing intake structure partially occupies sovereign land and is also included in the proposed lease.

- Although the intake structure extends approximately 65-feet into the bed of Mowery Slough, which is approximately 150-feet wide at this location, the structure does not appear to constitute a hazard to the public trust for commerce, navigation and fisheries. Relative to the proposed poleline, the wires will be a minimum of 30-feet above the elevation of Mean High Water and will be designed for easy removal in the event it is necessary for the passage of a large vessel. The only known vessel using Mowery Slough that would necessitate the taking down of the electrical wires is Leslie's own dredge, the Mallard.
- 3. This project is exempt from CEQA under Class 1, Section 2905, Title 2 of the Cal. Adm. Code (intake Structure) and Section 15103 of Title 14 of the Cal. Adm. Code (new Overhead Line).
- 4. The project is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in use category "A" which

LAND DESCRIPTION

A parcel of tide and submerged land lying in the bed of Mowry Slough situate in the City of Fremont, County of Alameda, State of California, being more particularly described as follows:

BEGINNING at a point in the southerly line of Parcel "P" as described in the deed from Leslie Salt Co. to the State of California, recorded February 1, 1968, on Reel 2119, Image 305, Official Records of Alameda County, said point being the westerly terminus of that certain course having a bearing of S 58° 48' 54" W 222.1 feet; thence along said course N 58° 48' 54" E 40.0 feet; thence N 4° 07' 30" W 156.22 feet to an angle point in the northerly line of said Parcel "P" as said line is shown on that Record of Survey No. 551, recorded in Book 10 of Records of Survey at pages 29-85, Alameda County Records, said point being the easterly terminus of that course having a bearing of N 72° 44' 51" E 168.6 feet; thence along said course 5 /2° 44' 51" W 82.15 feet; thence S 4° 07' 30" E 154.50 feet to intersection with southerly line of said Parcel "P"; thence along said southerly line N 87° 30' 38" E 44.40 feet to the point of beginning.

This description is based on the California Coordinate System, Zone 3. All distances are grid distances. To obtain ground distances, multiply the grid distance by 1.0000587.
