TIMBER SALE AGREEMENT IN SISKIYOU COUNTY

In furtherance of the timber management program endorsed at the May, 1980 Commission meeting, the staff has prepared a harvest plan and solicited sealed bids for the sale of 234,000 board feet of commercial sawtimber within a 200-acre parcel of State school land, 11 airline miles south of Yreka in Siskiyou County.

The sale was advertised in April in local and regional newspapers and bid packages sent to a mailing list of over 70 operators in Northern California. One bid was received as of May 3, the bid opening date, in the amount of \$22,563 submitted by Simpco Landa. This is \$171 above the appraised value determined by staff in March 1983.

- 1. A Negative Declaration (No. 312) was prepared by Commission staff which was certified by the Commission at its September 1982 meeting. A Timber Harvest Plan has been filed with the California Department of Forestry.


