LETTER OF PERMISSION - NOVATO SANITARY DISTRICT

PRC 6452.9

NOVATO SANITARY DISTRICT HAS REQUESTED PERMISSION FOR DIKE MAINTENANCE IN NOVATO CREEK AND RECONSTRUCTION OF TIDE GATES IN SIMON SLOUGH, MARIN COUNTY.

IN RESPONSE TO THE DISTRICT'S DESIRE TO COMPLETE THIS PROJECT PRIOR TO THE RAINY SEASON, I HAVE ISSUED A LETTER AUTHORIZING THE ABOVE-MENTIONED WORK.

THE DISTRICT HAS AGREED TO OBTAIN A GENERAL PERMIT - PUBLIC AGENCY USE AS SOON AS POSSIBLE IN ACCORDANCE WITH COMMISSION RULES AND REGULATIONS. THEY ARE IN THE PROCESS OF OBTAINING THE NECESSARY PERMITS FROM THE U. S. ARMY CORPS OF ENGINEERS, DEPARTMENT OF FISH AND GAME, SAN FRANCISCO BAY CONSERVATION AND DEVELOPMENT COMMISSION AND MARIN COUNTY.

LETTER OF PERMISSION - STATE BOARD OF RECLAMATION

A LETTER OF PERMISSION WAS GRANTED TO THE STATE RECLAMATION BOARD IN ADVANCE OF A ROUTINE PERMIT TO ENTER UPON SUBMERGED LAND IN THE SACRAMENTO RIVER TO CONSTRUCT BANK PROTECTION IN TEHAMA COUNTY. THE BID PROCESS IS SCHEDULED TO BEGIN JULY 21, 1983, PREVENTING THE STATE RECLAMATION BOARD FROM OBTAINING A FORMAL PERMIT.

THEY HAVE AGREED TO APPLY FOR A PERMIT WITHIN 60 DAYS.
