OTHER PERTINENT INFORMATION:

- 1. The work to be done under the proposed permit involves maintenance of an existing levee to prevent flooding of properties that were inundated in 1983 and that are on the site of a proposed major waste water reclamation disposal project being undertaken by the applicant.
- 2. The State Lands Commission approved a letter of authorization for this project on July 21, 1983, conditioned upon applicant obtaining a General Permit Public Agency Use.
- Due to minimal staff time expended, staff recommends waiver of processing and expense fees.
- 4. The annual rental value of the site is estimated to be \$6,508.22.
- 5. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class 2 and Class 4(2), Repair and Reconstruction of Facility, 2 Cal. Adm. Code 2905.
- 6. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.


