LEASE OF SCHOOL LAND FOR A RADIO TRANSMITTER SITE  
- PRC 6458.2

ON JULY 21, 1983 THE COMMISSION APPROVED A LEASE, TO CITY NEWS SERVICE, INC., OF A PARCEL OF SCHOOL LAND NEAR TRUCKEE, FOR A RADIO TRANSMITTER SITE. THE COMMISSION'S AUTHORIZATION INCLUDED A ROAD RIGHT OF WAY, AND UTILITY RIGHT OF WAY, IN ADDITION TO THE ANTENNA SITE. THE LESSEE HAS BEEN FINALIZING THE DESIGN AND OBTAINING REGULATORY AGENCY APPROVALS DURING THE PAST YEAR. THEY ARE NOW SCHEDULED TO START CONSTRUCTION IN JULY OF THIS YEAR.

DURING FINAL DESIGN IT WAS DETERMINED THAT AN ADDITIONAL UTILITY CORRIDOR ACROSS STATE LAND IS NECESSARY. THE LESSEE HAS AGREED TO AMEND THE EXISTING LEASE, AND CONSIDERATION OF THIS AMENDMENT WILL BE ON AN UPCOMING COMMISSION CALENDAR.

HOWEVER, TO ENABLE OUR LESSEE TO MEET THEIR CONSTRUCTION TIMETABLE, THEY HAVE REQUESTED A TEMPORARY RIGHT OF ENTRY PERMIT ALLOWING CONSTRUCTION IN THE ADDED UTILITY AREA, PENDING APPROVAL OF THE LEASE AGREEMENT. WITH YOUR PERMISSION, I WILL EXECUTE A TEMPORARY RIGHT OF ENTRY PERMIT TODAY.
