AREA, TYPE LAND AND LOCATION:

Immediate vicinity of water sources situated in arid regions on school lands as follows: Section 36, T15N R16E; Section 16, T11N, R14E; Section 36, T7N R12E; and Section 36, T4N R20E; all SBM, in San Bernardino County.

LAND USE:

Posting of signs in proximity of water holes, springs, seeps and other watering places limiting use by public to preserve, protect and restore wildlife.

TERMS OF PROPOSED AGREEMENT:

Initial period:

Ten years beginning June 1, 1984.

Special:

The posted signs enjoin the public not to camp, picnic or nemain within 200 yards of the posted water scurce.

CONSIDERATION: No monetary charge. The public benefit, with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

- On June 27, 1974, the State Lands Commission authorized issuance to the Department of Fish and Game of a ten-year public agency permit, PRC 4920.9, commencing June 1, 1974. Said permit allowed the posting of specified signs near waterholes located on State school lands hereinabove described, enscining the public not to camp, picnic on stay within 200 yards of the posted waterhole. A provision of the original permit stated it shall not convey any property rights other than authority for posting of the signs, this provision has been carried forward in the new Agreement.
- Prior to the May 31, 1984 expiration of Public Agency Permit No. PRC 4920.9, the Department of Fish and Game was notified. In response, the Department head informed there was a need to retain the program and an Agreement was requested. In place of a Public Agency Permit an Interagency Agreement of comparable coverage has been used. A revised Section 730, of Title 14, Cal. Adm. Code since the original permit . was issued, no longer requires the identification of specific desert water sources in order to qualify them for protection under the provisions of the Section. However, the Agreement specifies the Department shall in a timely manner provide the Commission with the Section, Township, Range and Meridian for school land upon which sighs are posted on or after June 1, 1984.
- The annual rental value of the site is estimated to be \$20.00.
- 4. This activity involves lands ident ided as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Such lands are described as follows: Section 36, T15N, R16E; Section 16. T11N, R14E; Section 36, T4N, R20E; all SBM. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.


