AREA, TYPE LAND AND LOCATION:

State Oil and Gas Lease PRC 2726.1 contains  
4250.14 acres of tide and submerged land,  
located in Santa Barbara County.

LEASE SUMMARY:

State Oil and Gas Lease PRC 2726.1 was issued  
on May 4, 1961, to Richfield Oil Corporation  
(now Atlantic Richfield Company), the Ohio Oil  
Company (now Marathon Oil Company), Socony  
Mobil Oil Company, Inc. (now Mobil Oil  
Corporation) and Tidewater Oil Company (now  
Getty Oil Company) pursuant to competitive  
public bidding. Mobil Oil Corporation is  
presently acting as operator.

Assignment forms have been executed by Getty  
Oil Company (Assignor) and Mobil Oil Corporation  
(Assignee) and they request that the State  
Lands Commission consent to the partial  
assignment of Assignor's undivided 50 percent  
of 75 percent of its undivided 11.1 percent  
plus 0.05 percent interest in State Oil and Gas  
Lease PRC 2726.1 to Assignee. Total undivided  
interest in State Lease 2726.1 assigned to  
Assignee is 4.2125 percent.
