MAINTENANCE DREDGING POLICIES

At the request of industry and permittee representatives, State Lands Commission staff has reviewed maintenance dredging policies.

Dredging projects range from a few thousand cubic yards up to over a million cubic yards. The Commission imposes royalties and authorizes commercial dredging for materials such as oyster shells or gravel or sand. In the case of maintenance dredging, charges are made to permittees when spoils are put on private uplands or in a submerged location where the spoils become unrecoverable. Governmental agencies are not charged when their dredging activities are considered to be in the public benefit, and spoils are not deposited on commercial or private properties.

Staff has prepared a report on dredging policies and developed several recommendations for changes to current policy. Staff requests permission to circulate the Preliminary Review of State Lands Commission Maintenance Dredging Policies for a forty-five day public comment and review.

Copies of the report are on file at the main office of the Commission.
