TERMINATION OF PRC 6748  
GENERAL PERMIT - RECREATIONAL USE AND  
ACCEPTANCE OF A QUITCLAIM DEED

LESSEE: Franklin D. Ramos  
246 Ebbets Pass Road  
Vallejo, California 94590

AREA, TYPE LAND AND LOCATION:  
A 0.031-acre parcel of tide and submerged land,  
located in Steamboat Slough at Martin's Island,  
Solano County.

LAND USE: Construction and use of a boat dock and walkway.

TERMS OF ORIGINAL PERMIT:

Initial period: Ten years beginning October 1,  
1984.

Public liability insurance: Combined single  
limit coverage of \$100,000.

Consideration: \$80 per annum; five-year rent  
review.

PREREQUISITE ITEMS:

- A. Lease Quitclaim Deed has been duly executed  
by lessee.
- B. An inspection of the State parcel was  
conducted and the facilities were removed.
- C. All rental payments were current upon the  
lessee's notification date to staff.

1. The Lessee has requested termination of the lease due to destruction of the facilities during the 1986 winter flooding.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

A parcel of tide and submerged land in the bed of Steamboat Slough (Snug Harbor), Solano County, California, described as follows:

All that land lying immediately beneath a floating dock TOGETHER WITH a necessary use area extending 10 feet from the extremities of said dock, said dock being adjacent to that parcel of land described in the Grant Deed recorded April 3, 1984, Page 27108, Solano County Records (APN 48-280-04).

EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark.

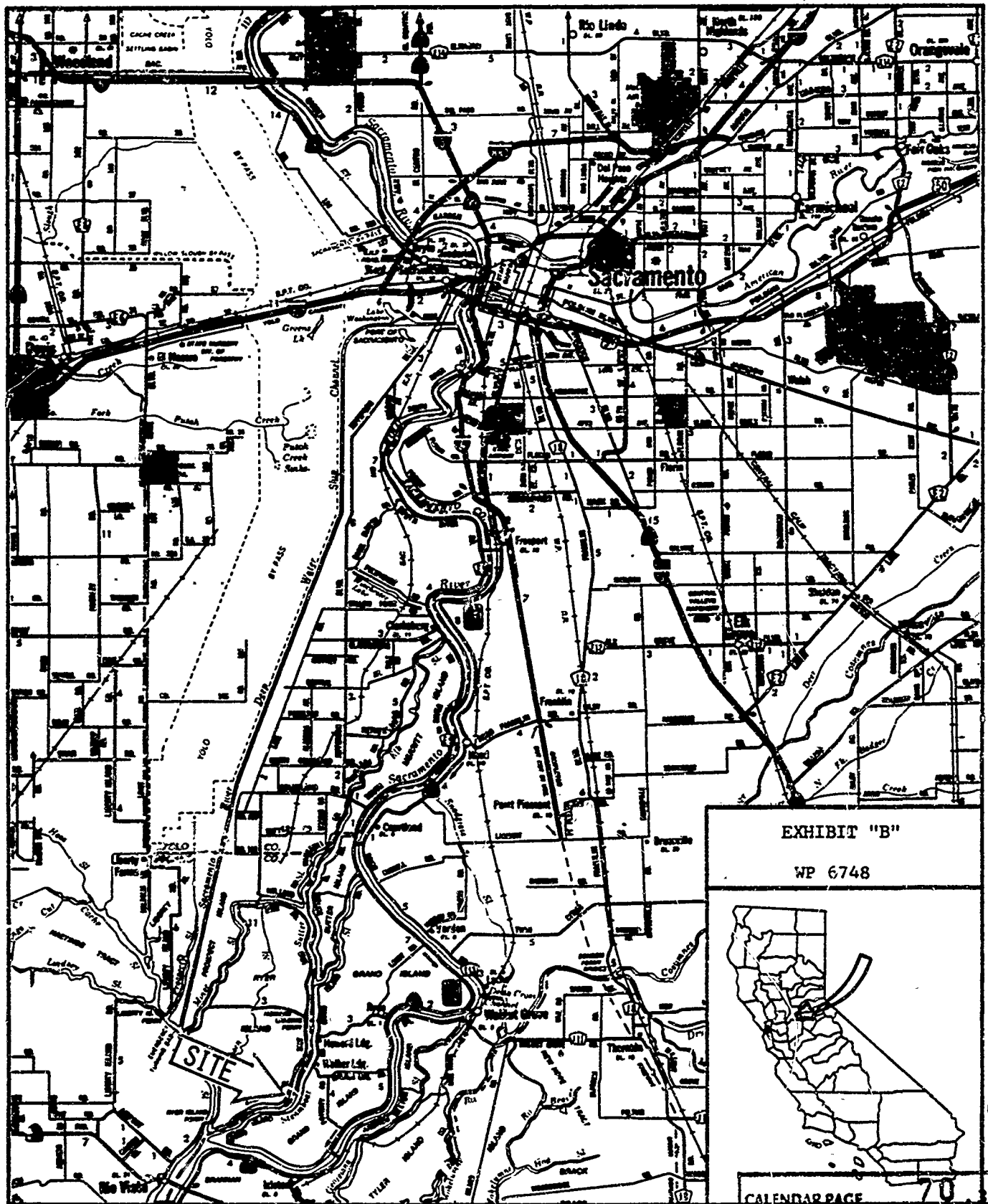
