## **BACKGROUND:**

On April 25, 1985, Minute Item No. 14, the State Lands Commission approved a Master Lease to Pacific Gas and Electric Company (PG&E) for various electrical energy distribution facilities located throughout the State.

The Master Lease allows for changes and new facilities to be added by an addendum to the Master Lease. The lease further specifies that no filing or processing fees shall be required for minor modifications to the Lease.

## **CURRENT SITUATION:**

PG&E has requested a permit to install a proposed overhead power line across the Eel River in the southwest quarter of Section 5. Township one north, Range one east, Humboldt Base and Meridian.

## TERMS OF ORIGINAL LEASE:

Initial Period: 30 years beginning May 1, 1985

Renewal Options: One successive period of

15 years.

Public Liability Insurance:

Combined single limit coverage of \$2,000,000.

#### LAND DESCRIPTION

A strip of submerged land 40 feet wide in the bed of the Bel River near Rio Del, Section 5. TlN, RIE, HM, Humboldt County, California, the centerline of said strip being described as follows:

BEGINNING at a point on the south line of said Section 5 from which the projected southwest corner thereof bears West 875 feet, more or less; thence N 0014'30" W. 60 feet, more or less, to Station 'PS' 7+18.9 as shown on Pacific Gas and Electric Drawing No. RA-114, a copy of which is on file with the State Lands Commission, thence N 2033'42" Z 1000 feet to the end of the herein described line.

EXCEPTING THEREFROM any portion lying landward of the ordinary low water marks of the Eel River.
