SCHOOL LAND SALE

OTHER PERTINENT INFORMATION:

1. The parcels of land proposed for sale to the City of Los Angeles and the Intermountain Power Agency were erroneously omitted from the school land sale authorized by the Commission at its August 21, 1984 meeting. These parcels are within the existing right-of-way of the 500 KV transmission line providing service to Los Angeles Basin. The City of Los Angeles and the Intermountain Power Agency have agreed to purchase these parcels. The staff of the Commission has reviewed valuation information on the lands involved and the purchase price of \$8,400 is based on that review.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the California Environmental Quality Act (CEQA) under the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. The staff believes there is no possibility that this project may have a significant effect on the environment.
3. A review by the Commission indicates the subject parcels are not suitable for cultivation, without artificial irrigation, and as such, may be sold for a price set by the Commission.
4. In compliance with Section 6373 of the P.R.C., a General Plan has been prepared and filed with the Legislature.

(CALENDAR ITEM NO. 03 (CONT'D))

IT IS RECOMMENDED THAT THE COMMISSION AS SCHOOL LAND BANK TRUSTEE:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 BECAUSE THERE IS NO POSSIBILITY THAT THE ACTIVITY MAY HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT. (14 CAL. ADM. CODE 15061(b)(3)).
2. FIND THAT THE STATE SCHOOL LANDS, DESCRIBED IN EXHIBIT "A", ATTACHED HERETO, ARE NOT SUITABLE FOR CULTIVATION WITHOUT ARTIFICIAL IRRIGATION.
3. AUTHORIZE THE SALE AND SUBSEQUENT ISSUANCE OF PATENTS TO THE INTERMOUNTAIN POWER AGENCY OF THE LAND DESCRIBED IN EXHIBIT "B" AND THE CITY OF LOS ANGELES, OF THE LANDS DESCRIBED IN EXHIBIT "A", SUBJECT TO ALL STATUTORY AND CONSTITUTIONAL RESERVATIONS, INCLUDING A RESERVATION FOR ACCESS TO OTHER STATE LANDS.
4. AUTHORIZE THE DEPOSIT OF \$8,400 IN THE SCHOOL LAND BANK FUND.
