Public liability insurance: Combined single limit coverage of \$100,000.


CONSIDERATION: \$175 per annum; with the State reserving the right to fix a different rental on each fifth anniversary of the permit.

#### OTHER PERTINENT INFORMATION:

- The subject recreational cabin, owned by Robert G. and Eileen L. Schuck, is an existing structure located in the Napa River at Dutton's Landing, off Green Island Road. The cabin is not used for residential purposes, and has been rented by the Schuck's to a group for occasional fishing. With the exception of a chemical toilet that has been installed on the upland, water and sewage utilities are not available to the site. Vehicular access is not available directly to the site, but may be obtained to a point, using lands owned by Leslie Salt Company. The Schuck's have obtained a license for access from Leslie Salt.
- 2. As set forth in the proposed permit, the Schuck's understand and agree that the recreational cabin may only be used on a part-time basis for recreational activities consistent with the public trust, and may not be used for residential purposes. In addition, the proposed permit calls for the removal of the improvements in the event they are destroyed or otherwise rendered uninhabitable.
- 3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
