AUTHORIZATION TO EXTEND CONSTRUCTION LIMITING DATE

BACKGROUND .

The Commission, at its meeting of March 23, 1982, Minute Item 14, approved the issuance of a General Lease - Right-of-Way Use to California Fish Growers, Inc., for construction and use of intake and outfall water pipelines to support an onshore fish farm facility, located in the Pacific Ocean at Bodega Bay, Sonoma County. The Commission authorized extension of construction limiting date, at its February 24, 1983 meeting, to March 31, 1986, with a minimum rental rate applicable until completion of construction or the limiting date, whichever occurred first.

CURRENT SITUATION:

California Fish Growers, Inc. has decided to scale the project down to a small experimental pilot farm for the present, delaying the need to construct the water pipelines. However, they plan to expand the project within the next year, therefore, the Lessee requests that the construction limiting date be extended to May 31, 1989.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.
