Under a joint agreement between Glenn and Colusa counties, the cable ferry was funded and operated by both counties. In July 1986, due to a lack of funding, Glenn County withdrew from the joint agreement and the ferry has since been inoperable. The County of Colusa now wishes to continue with the ferry operations and maintenance.

## OTHER PERTINENT INFORMATION:
