#### BACKGROUND:

On April 25, 1985, Minute Item No. 14, the State Lands Commission approved Master Lease PRC 6827 to Pacific Gas and Electric Company (PG&E) for various over 60 KV electrical energy transmission facilities located throughout the State. On August 26, 1982, Minute Item No. 19, the State Lands Commission approved Master Lease PRC 6205 to PG&E for various under 60 KU electrical distribution facilities located throughout the State.

Each Master Lease allows for changes and new facilities to be added by addendum to the Master Leases. The leases further specify that no filing or processing fees shall be required for minor modifications to the Master Leases.

## CURRENT SITUATION:

On August 10, 1988, the State Lands Commission approved a permit to Continental Telephone Company of California, for use of existing power poles owned by PG&E across the Merced River. Staff found that this existing crossing for an over 60 KV transmission line and an under 60 KV distribution line was not under permit to PG&E. These addendums will amend PG&E's Master Leases to include the existing crossing, a 0.241-acre parcel of submerged land in the Merced River.


