AUTHORIZATION TO SOLICIT BIDS FOR THE REMOVAL OF HAZARDOUS STRUCTURES ON TIDE AND SUBMERGED LANDS

The Commission was provided \$563,000 funding in the 1988-89 fiscal year to remove priority hazards identified in the Commission's Coastal Hazards Inventory Program to the Legislature, June 1986. These hazards scheduled for removal are located in Santa Barbara and Los Angeles counties identified as follows in priority order:

Santa Barbara channel near the City of Goleta. The hazard comprises the remains of five, and possible six, former oil drilling piers.

North shore of Santa Barbara channel at Santa Barbara; beach at Biltmore Hotel at Crys/cal Casino. Remains of three steel sheet-pile groins extending across beach and into surf.

North coast of Santa Barbara channel at Santa Barbara; beach across from Biltmore Hotel. Remains of two piers (approximately 16 piles).

North coast of Santa Barbara channel at Ellwood. Remains of 15 oil piers, comprising numerous steel H-beam piles.

Santa Monicà Municipal pier. Old pier pilings (approximately 50) protruding less than three (3) feet above sand levels.

Santa Monica Bay shoneline adjacent to southern boundary to the City of Santa Monica. Old pier pilings which are exposed during winter months.

Northern coastline of Santa Barbara channel east of community of Summerland. Row of H-beam posts surrounding concrete seawall.

Pacific Ocean coastline at Jalama Beach County Park, Santa Barbara County. Steel wreckage and debris, reportedly from steel barge which is occasionally uncovered and moved by heavy surf.

The solicitation for bids contains the provision that the Commission will select, on a priority basis, the sites that will be contracted for, based on the funding limitation of \$563,000.
