The suggested changes provide, in part, a definition of a development project and also require the applicant to indicate whether the application for Commission action falls within said definition of a development project.

In addition, the application forms have been modified to advise applicants of related notice requirements which are applicable to their items. The forms advise that, if the applicant wishes for the "deemed approved" provisions of the law to apply to their project, they must comply with the specified general notice provisions and that a copy of the Commission's mailing list is available upon request for the transmittal of such
