AUTHORIZATION FOR PREPARATION AND PROCESSING  
OF A STATE PATENT TO BE ISSUED TO  
JAMES COCHRAN

APPLICANT: James Cochran

James Cochran purchased 120 acres of school land in San Luis Obispo County on October 16, 1884. A Certificate of Purchase was issued August 17, 1885 and the property was fully paid for on November 2, 1885. Mr. Cochran is entitled to a State patent, but he has never obtained one.

The original Certificate of Purchase is beyond the control of the current land owner, The Hearst Corporation. In order to complete a chain of title to the current owner, a State patent needs to be issued in the name of James Cochran, the original purchaser.

Staff has examined the file and other information submitted by the current owners and has concluded that the laws relating to issuance of a patent have been complied with, and that the person to be named in the patent, James Cochran, is entitled to it.



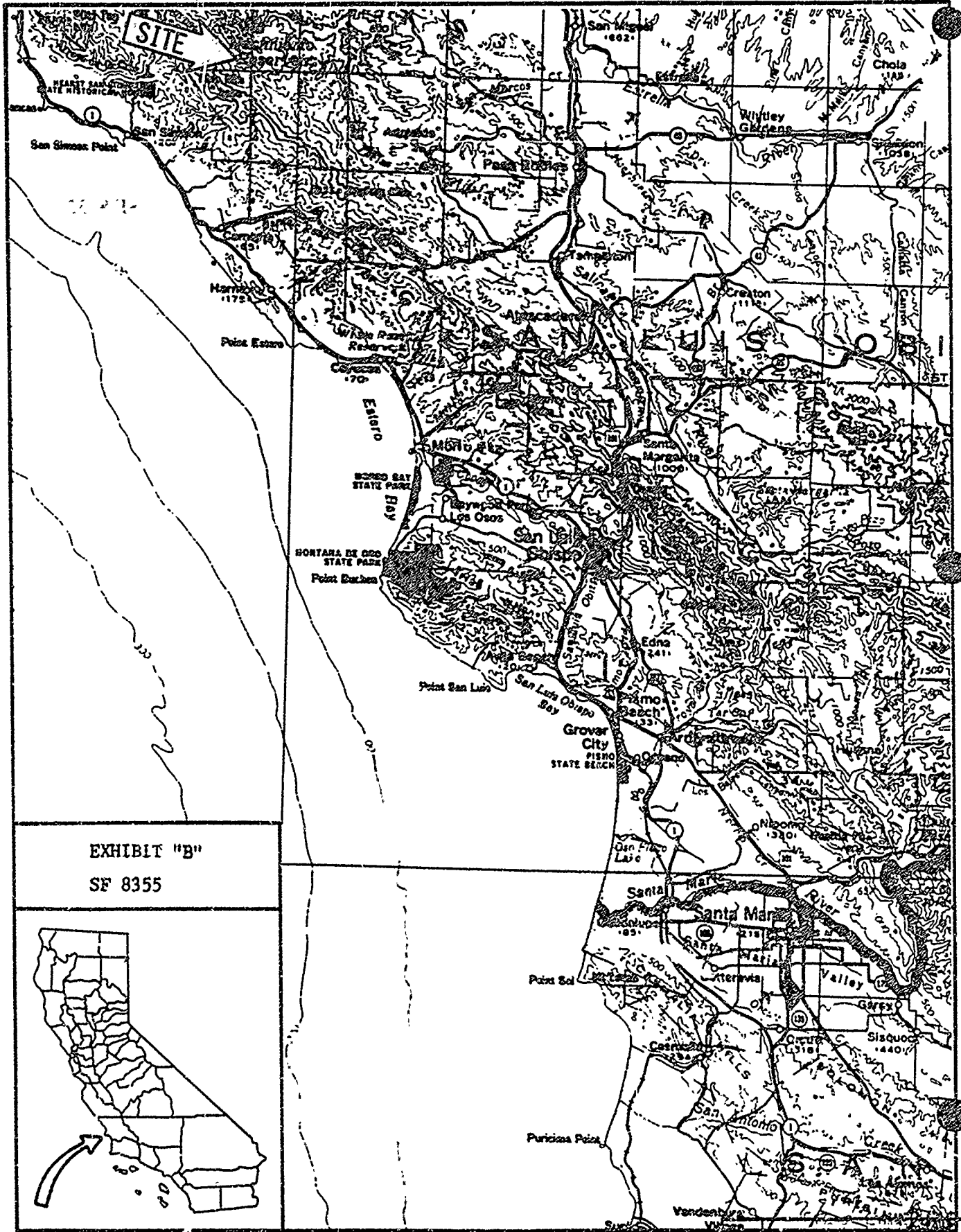
