RESISSUANCE OF GENERAL PERMIT - PUBLIC AGENCY USE

APPLICANT: California Department of Fish and Game
1416 Ninth Street
Sacramento, California 95814

AREA, TYPE LAND AND LOCATION:
Selected submerged land areas in the Klamath
River Drainage System, Klamath and Shasta
rivers, Siskiyou County.

LAND USE: Continued use and maintenance of selected King
Salmon spawning habitat areas.

TERMS OF PROPOSED PERMIT:
Initial period: Fifteen years beginning
February 1, 1990.

CONSIDERATION: The public use and benefit; with the State
reserving the right at any time to set a
monetary rental if the Commission finds such
action to be in the State's best interest.

BASIS FOR CONSIDERATION:
Pursuant to 2 Cal. Code Regs. 2003.

APPLICANT STATUS:
Applicant is permittee of upland.

PREREQUISITE CONDITIONS, FEES AND EXPENSES:
Filing fee has been received.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities, 14 Cal. Code Regs. 15301(i).

Authority: P.R.C. 21084 and 14 Cal. Code Regs. 15300.
2. Under the permit issued by Minute Item No. 3 on February 2, 1982, The Department of Fish and Game was issued and eight- (8) year permit for rehabilitating selected salmon spawning areas in the Klamath River Drainage System. The permit included any State interest in the Klamath and Shasta rivers for the support of anadromous fishery. This permit will allow the continuation of the rehabilitation program.
3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. but will not affect those significant lands.
4. The annual rental value of the sites combined is estimated to be \$90.
5. The Applicant has requested the processing fee be waived due to the fact that this continuing project benefits the public by increasing salmon population in the Klamath River System.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 AS A CATEGORICALLY EXEMPT PROJECT, CLASS 1, EXISTING FACILITIES, 14 CAL. CODE REGS. 15301(i).
2. FIND IT IN THE STATE'S BEST INTEREST TO WAIVE THE PROCESSING FEE.
3. AUTHORIZE ISSUANCE TO CALIFORNIA DEPARTMENT OF FISH AND GAME OF A FIFTEEN-YEAR GENERAL PERMIT - PUBLIC AGENCY USE, BEGINNING FEBRUARY 2, 1990; IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT, WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR KING SALMON SPAWNING HABITAT REHABILITATION PROJECTS ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

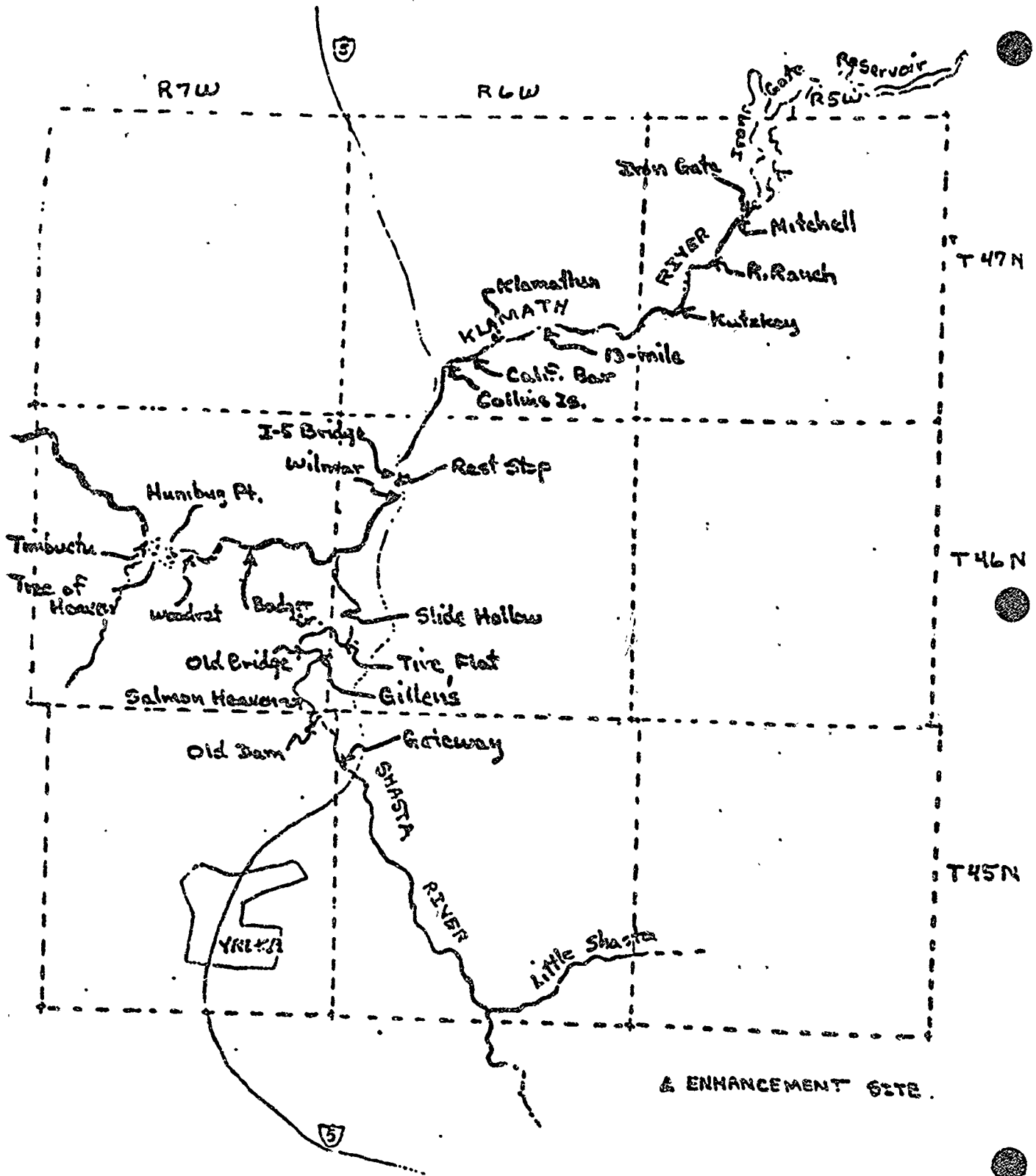


Figure . Location map of proposed enhancement sites on the Klamath and Shasta Rivers.

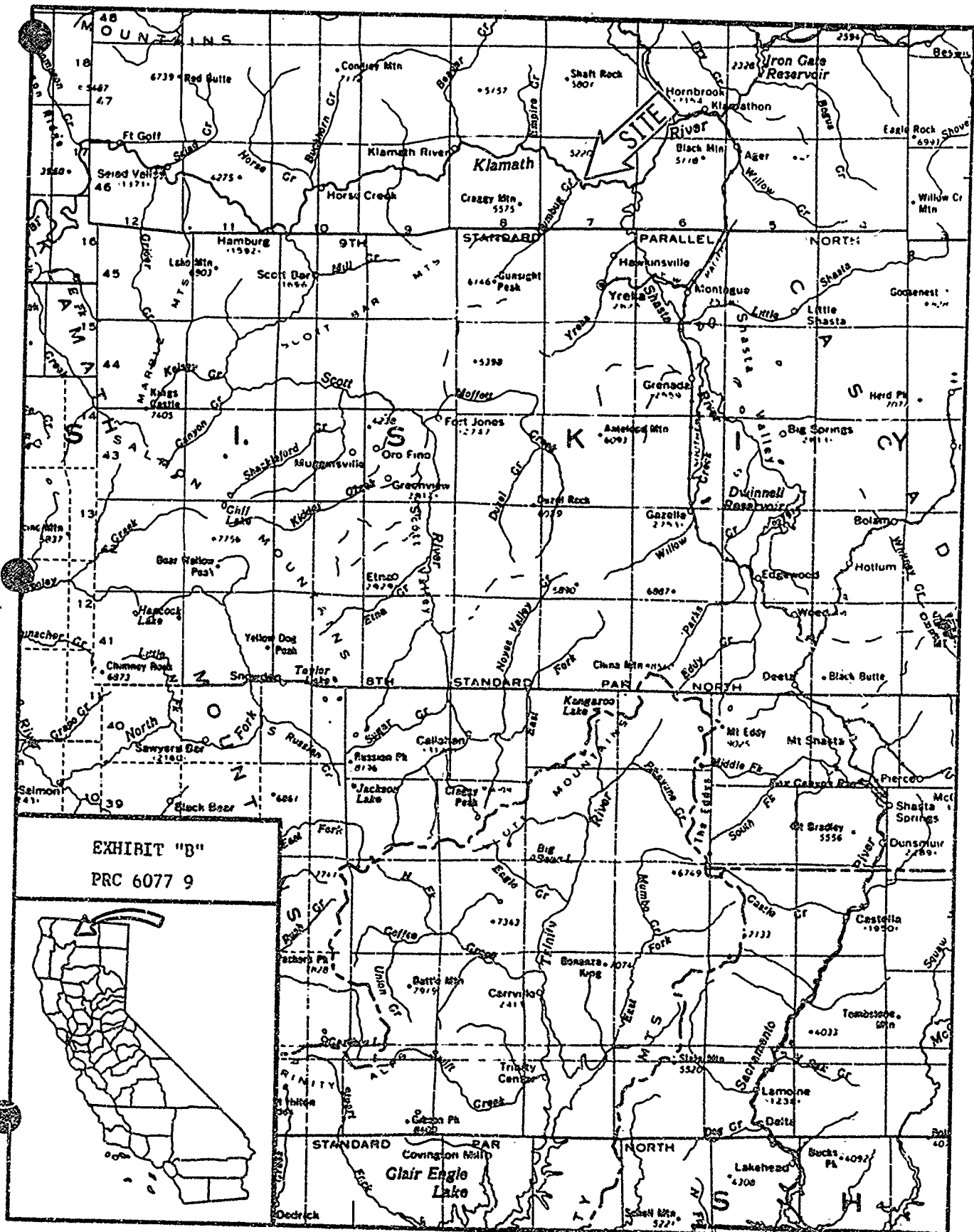
