### OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 2, Replacement or Reconstruction, 14 Cal. Code Regs. 15302.

Authority: P.R.C. 21084 and 1/4 Cal. Code Regs. 15300.

2. The Applicant has requested this right of entry for the purpose of entering the property for work involved in the construction of a replacement bridge across the Smith River. The previous suspension bridge was so badly damaged in a truck accident that it had to be removed.

The design of the replacement structure and its appurtenant roadway approaches is in conformance with existing federal standards. The additional shoulder widths are the result of a Department of Parks and Recreation request for safe pedestrian and bicycle public access, an aspect not previously available on the old bridge.

Also, the Department of Transportation will not be utilizing the staging area as previously indicated in the United States Army Corps of Engineers Public Notice 18103N55. Although the existing gravel bar will be used, no bridge will be constructed and no material will be placed in the river.

Upon completion, Caltrans will follow through with the filing of a right-of-way map, as required by Section 101.5 of the Streets and Highways Gode of the State of California.

- 3. The issuance of this right of éntry is conditioned upon Caltrans obtaining all of the required permits to proceed with the project and not occupying the premises until all such permits have been obtained.
- 4. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq.
