APPROVE COMMISSION MEMBERSHIP AND DESIGNATE ITS REPRESENTATIVE TO THE BOARD OF DIRECTORS OF THE NEWLY FORMED COLSA CHICA CONSERVANCY

### **BACKGROUND:**

On May 22, 1989, the Bolsa Chica Planning Coalition (Coalition) adopted a Concept Plan as an alternative to the Bolsa Chica Land Use Plan conditionally certified by the California Coastal Commission in January 1986. The Coalition's Executive Committee is comprised of representatives of the County of Orange, City of Huntington Beach, Signal Landmark, Amigos de Bolsa Chica, and the State Lands Commission. Additional members of the Coalition include other affected local, State and federal agencies, other landowners and a broad range of interested citizen organizations.

As an adjunct to its Concept Plan, the Coalition adopted a set of "Support Policies for Plan Components." Among these is the provision that:

 A Conservancy will be formed to monitor the restoration effort at Bolsa Chica, to establish an educational/administrative facility, and will be managed by a board of directors.

- 2. Coalition members will constitute the initial members of the Conservancy's board of directors. A.board of trustees will be formed to assist the board of directors in an advisory capacity. The board of trustees should include members from the fields of education, business, finance, environmental concerns, local citizens, and other interested public or private agencies.
- The State Coastal Conservancy will be requested to assist in the formation of such a Conservancy."

The early formation of a conservancy could have substantial public benefit as the Coalition proceeds to have its plan adopted by the appropriate public agencies. Accordingly, Signal Landmark, at the urging of the Amigos de Bolsa Chica, offered its assistance in filing Articles of Incorporation for "The Bolsa Chica Conservancy" to be organized under the Nonprofit Public Benefit Corporation Law for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

The specific purposes for which this corporation is being organized include, but are not limited to, the preservation, restoration, and enhancement of Bolsa Chica for fish and wildlife habitat, and wetland and estuarine resources and their uses for scientific, historic, educational, ecological, recreational, scenic and open space opportunities. All activities of the Bolsa Chica Conservancy shall be consistent with and supportive of the State Department of Fish and Game's management of the expanded Bolsa Chica Ecological Reserve.

In order to file the Articles of Incorporation, it is necessary to name the members of the organization's Board of Directors. It is proposed that the Conservancy's Board will be comprised of the existing five members of the Coalition's Executive Committee.

Since its formation in October 1988, James F. Trout, the Commission's Assistant Executive Officer and Daniel Gorfain, Senior Staff Manager, Division of Research and Planning, have represented the Commission on the Bolsa Chica Planning Coalition. Staff recommends that this representation be reaffirmed for the Commission's participation on the board of the Bolsa Chica Conservancy.

# ARTICLE II

- A. This organization is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.
- B. The Specific purpose for which this corporation is organized include, but are not limited to the preservation, restoration and enhancement of Bolsa Chica for scientific, historic, educational, ecological, recreational, wetlands, scenic and open space-opportunities.

### ARTICLE IV

- A. The corporation is figanized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- B. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of said Code, or the corresponding provisions of any future statute of the United States.
- C. No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation; nor shall the corporation participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
