RATIFY AUTHORITY TO AWARD AGREEMENT  
TO THE LOWEST BIDDER, SACHSE ENGINEERING ASSOCIATES, INC.  
TO CONDUCT A SEA FLOOR HAZARDS SURVEY WITHIN  
THE COASTAL WATERS OF SANTA BARBARA, VENTURA,  
LOS ANGELES, AND ORANGE COUNTIES

The Commission was provided, through an Interagency Agreement with the Environmental Affairs Agency, \$600,000 funding to conduct a sea floor hazards survey in an area of State coastal waters in offshore Santa Barbara, Ventura, Los Angeles, and Orange counties, California. This is part of the Fisheries Mitigation Program funded by State 8(g) revenues. The solicitation for bids has been made. The bid price of \$248,835 was for competitive purposes only. The line miles of ocean floor to be surveyed has been increased from 891 line miles to 1,508 line miles and the number of targets to be confirmed has been increased from 100 to 150 targets. The contract price of \$429,883 represents the extrapolated cost which takes into consideration the increase of the number of line miles and targets.
