BOUNDARY LINE AGREEMENT AD 134

PARTY:

Kahala Needles Partners Ltd., a Neuada limited partnership 2300 Paseo Del Prado, Suite B-107 Las Vegas, Neuada 89102

The staff of the State Lands Commission has negotiated a compromise settlement agreement with Kahala for the establishment of the ordinary high water mark (OHWM) as the boundary between the State-owned bed of the Colorado River, a navigable waterway, and the adjacent upland parcel of Kahala, all in San Bernardino County.

The proposed agreement contains quitclaims of the State to Kahala of the upland parcel, and of Kahala to the State of any interest in the Colorado River, as well as a 22-foot wide, nonmotorized easement for public access along and landward of the ordinary high water mark. Access to the 22-foot-wide easement is from adjacent City of Needles property to the north.

The staff believes it is in the best interest of the State to enter into the proposed agreement pursuant to the provisions of Division 6 of the P.R.C., with particular reference to Section 6357 and to define the extent, nature, location, and area of public and private titles and boundary by compromise settlement in order to avoid the costs and uncertainties of litigation.
