DREDGING PERMIT

PARTY: Donner Lake Property Owners Association
P. O. Box 8387
Truckee, California 95737

AREA, TYPE LAND AND LOCATION:
Ungranted sovereign lands at the west end of
Donner Lake at 15750 South Shore Drive, Nevada
County.

LAND USE: Excavate a maximum 50 cubic yards of material
to maintain a navigable depth as the area is
again covered by water, and provide material
for replenishment of the adjacent beach.

TERMS OF PROPOSED PERMIT:
Initial period: One (1) year beginning
December 12, 1990.
Royalty: \$0.25 per cubic yard for
material disposed of on the
adjacent private-use beach as
approved.

PREREQUISITE CONDITIONS, FEES, AND EXPENSES:
Filing fee and processing costs have been
received.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alterations to Land, 14 Cal. Code Regs. 15304(g)

Authority: P.R.C. 21084 and 14 Cal. Code Regs. 15100.

2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 AS A CATEGORICALLY EXEMPT PROJECT, CLASS 4, MINOR ALTERATION TO LAND, 14 CAL. CODE REGS. 15104(g).

2. FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.
3. AUTHORIZE ISSUANCE TO DONNER LAKE PROPERTY OWNERS ASSOCIATION, THE DREDGING PERMIT ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION. THE PERMIT SHALL ALLOW EXCAVATING A MAXIMUM 50 CUBIC YARDS OF MATERIAL FROM DONNER LAKE, NEVADA COUNTY, FOR ONE YEAR BEGINNING DECEMBER 12, 1990. THE DREDGED MATERIAL WILL BE USED FOR REPLENISHMENT OF A PRIVATELY USED BEACH. A ROYALTY OF \$0.25 PER CUBIC YARD SHALL BE CHARGED FOR THE MATERIAL DREDGED AND DISPOSED OF AS APPROVED. THE PERMITTED ACTIVITY IS CONTINGENT UPON THE APPLICANT'S COMPLIANCE WITH APPLICABLE PERMITS, RECOMMENDATIONS, OR LIMITATIONS ISSUED BY FEDERAL, STATE, AND LOCAL GOVERNMENT AGENCIES.
