AMENDMENT OF GENERAL PERMIT - PUBLIC AGENCY USE

APPLICANT: County of Lassen Public Works Department
707 Nevada Street
Susanville, California 96130

AREA, TYPE LAND AND LOCATION: Submerged land in the bed of Eagle Lake at the
Spaulding boat dock and ramp, Lassen County.

LAND USE: Extension of an existing boat dock and ramp,
including the dredging of 450 cubic yards of
material for the installation of the facilities.
The material is to be disposed of at an approved
upland landfill site.

TERMS OF ORIGINAL PROPOSED PERMIT:
Increase the volume of material to be dredged for
facilities installation from 450 cubic yards to
3,000 cubic yards. All other terms and
conditions of the permit shall remain in full
force and effect.

Royalty: No royalty shall be charged
because the project is for the
public benefit.

APPLICANT STATUS: Applicant is owner of upland.

OTHER PERTINENT INFORMATION:

1. The increased volume to be dredged is required to complete the installation of the dock and boat ramp. The dredged material will be disposed of at an approved upland site.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that his activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land, 2 Cal. Code Regs. 2905(d)(4).

Authority: P.R.C. 21084, 14 Cal. Code Regs. 15300, and 2 Cal. Code Regs. 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

APPROVALS OBTAINED:

Lassen County Planning Department, Department of Fish and Game, and Lahontan Regional Water Quality Control Board.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 AS A CATEGORICALLY EXEMPT PROJECT, CLASS 4, MINOR ALTERATION TO LAND, 2 CAL. CODE REGS. 2905(d)(4).
2. FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.
3. AUTHORIZE THE AMENDMENT OF A GENERAL PERMIT - PUBLIC AGENCY USE TO LASSEN COUNTY DEPARTMENT OF PUBLIC WORKS, EFFECTIVE DECEMBER 12, 1990 TO INCREASE THE VOLUME OF MATERIAL TO BE DREDGED FOR FACILITIES INSTALLATION FROM 450 CUBIC YARDS TO 3,000 CUBIC YARDS. NO ROYALTY SHALL BE CHARGED BECAUSE THE PROJECT IS FOR PUBLIC BENEFIT. \$0.25 PER CUBIC YARD SHALL BE CHARGED FOR ANY MATERIAL SOLD OR USED FOR COMMERCIAL PURPOSES, ALL OTHER TERMS AND CONDITIONS OF THE PERMIT SHALL REMAIN IN FULL FORCE AND EFFECT.

LAND DESCRIPTION

A parcel of submerged land in Eagle Lake, Lassen County, California, adjacent to Section 6, T32N, R11E, MDM, described as follows:

All that land within the dredge area including the dock and concrete ramps as shown on "Project Plan, Eagle Lake-Spalding Tract, R.C. &D. Measure", a copy is on file in File PRC 5112.9, in the office of the California State Lands Commission, Sacramento, California.

EXCEPTING THEREFROM any portion lying landward of the ordinary low water mark of Eagle Lake.

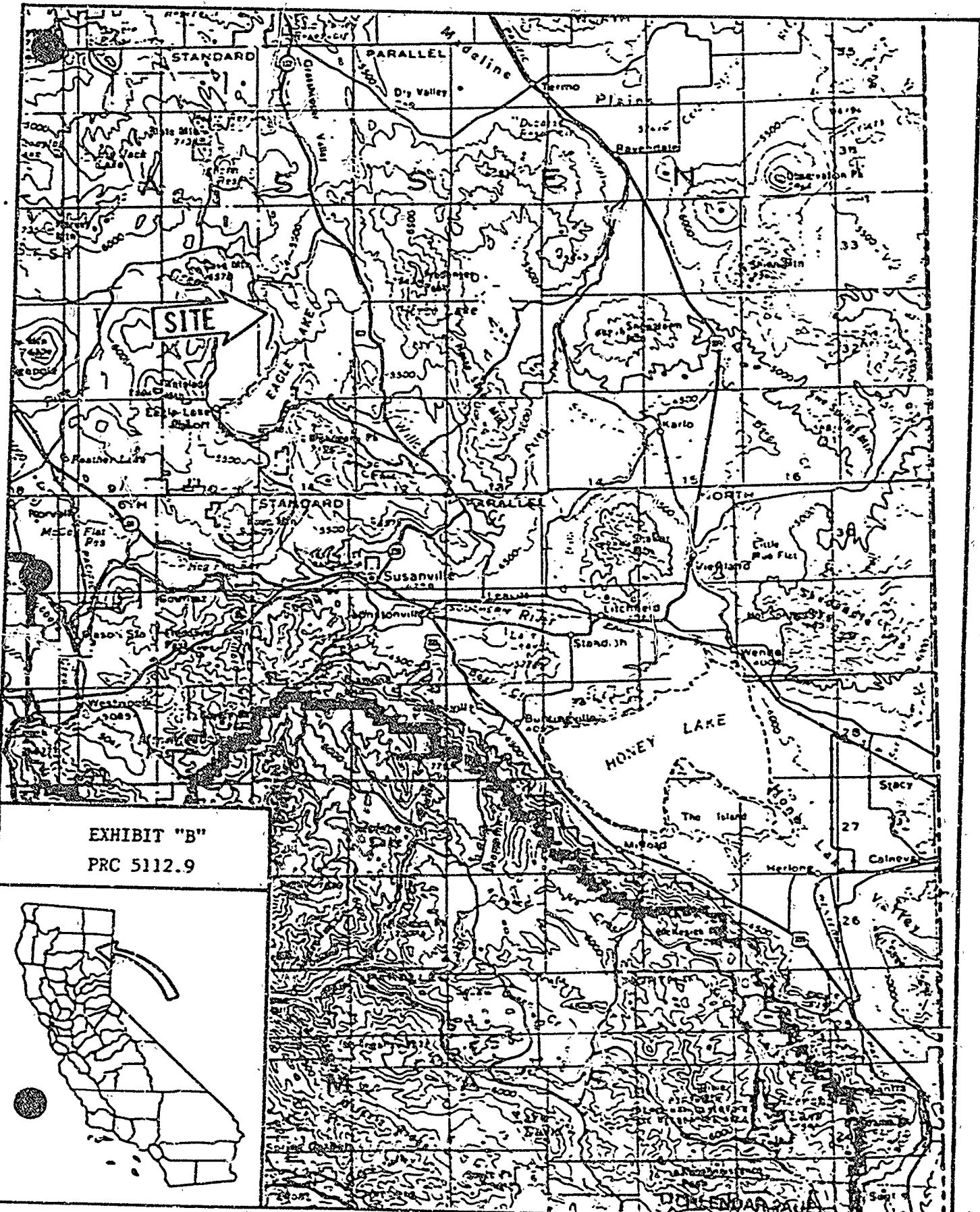
