APPROVE THE FOURTH MODIFICATION OF THE 1990-91 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET LONG BEACH UNIT, WILMINGTON OIL FIELD LOS ANGELES COUNTY

The City of Long Beach has requested approval of the Fourth Modification of the 1990-91 Plan of Development and Operations and Budget, Long Beach Unit. The Modification would augment the current budget by providing \$990,000 in additional funds including administrative overhead costs, for anticipated increased waste disposal costs until June 30, 1991. This would increase the total amount for waste disposal costs for the budget year to \$1,927,000 plus \$77,000 administrative overhead costs.

Last year's ('89/'90) plan and budget provided \$1.49 million for waste disposal costs of which \$1.42 million were actually spent. In late 1988, when the current ('90/'91) plan and budget was being formulated, it was expected that a proposed new unit waste disposal processing plant, which would substantially reduce disposal costs, would be on line by late 1990. As a result, only \$975,000 was budgeted for disposal costs in 1990-'91. However, jelay incurred in providing an available site for the new plant has set back the project to the point that it is now about one year behind schedule. As a result, an additional \$952,000 in disposal costs plus \$38,000 for administrative overhead are needed for the remainder of the current budget year.

In order to keep the current budget at its present funded level, the city was asked to provide the \$990,000 to transfers within the existing budget. The city responded that it is confident that virtually all of the funds presently provided in the budget will be spent by the end of the fiscal year. Therefore, an augmentation to the budget is required.



In accordance with the provisions of Part IV, Section A, of the 1990-1991 Plan and Budget, we are submitting for your approval the Fourth Modification of the Plan of Development and Operations and Budget of the Long Beach Unit covering the period July 1, 1990 through June 30, 1991.

The proposed Fourth Modification augments the Plan and Budget in the amount of \$990,000 for additional waste disposal costs through the end of the 1990-1991 budget period. The Oil and Gas Waste Disposal account was only partially funded in anticipation that the Pier J oil and water separation facility would be operational during the first half of 1991. Currently plans are for this facility to be operational in the 1991-1992 fiscal year.
