CONSENT TO MODIFICATION OF COOPERATIVE

WATER INJECTION AND GENERAL FACILITIES AGREEMENTS

FAULT BLOCK IV UNIT AND FAULT BLOCK V RANGER ZONE UNIT

WILMINGTON OIL FIELD, LOS ANGELES COUNTY

The Wilmington oil field is divided geologically into fault blocks that extend from the tidelands into the adjacent uplands. In the earlier developed part of the field, each of these fault blocks is unitized for oil and gas development. Among these units are the Fault Block IV Unit and the Fault Block V Ranger Zone Unit. The City of Long Beach, as tidelands trustee, is the Unit Operator of the tidelands segment (Segment I) of these Units. Mobil Oil Corporation is the Unit Operator of the uplands segment (Segment II) of these Units.

Mobil has sold all of its interests in Segment II of these Units and will resign as Unit Operator. The working interest owners in each of the Units will be selecting the City of Long Beach, in its proprietary capacity, as the Unit Operator for Segment II of each Unit to replace Mobil. The City will be selected because of its proprietary ownership of uplands parcels in these Units.

There exist numerous cooperative agreements involving the Fault Block IV Unit and the Fault Block V Ranger Zone Unit concerning water injection along parcel boundaries and the sharing of general facilities. There are nine (9) cooperative agreements which relate to oil operations on the tidelands and these are listed in Exhibit "A" which is attached. As a result of the replacement of Nobil by the City as Unit Operator for Segment II, the City in its proprietary capacity will succeed to Mobil's interests in these cooperative agreements.

Under section 10(b) of Chapter 29, Statutes of 1956, First Extraordinary Session, any modification of a contract or other agreement relating to the drilling for, developing, extracting, taking or removing, or disposition of oil, gas or other

hydrocarbons from the Long Beach tidelands must receive the consent of the State Lands Commission. The nine cooperative agreements for water injection and general facilities listed in Exhibit "A" are such agreements. Therefore, the assumption of the City of the interests previously held by Mobil under these agreements requires the Commission's consent.
