

RESOLUTION ESTABLISHING A SLOW AREA FOR BOATING AT SAN JOAQUIN POWER SQUADRON

MHEREAS, Section 4-4022 of the Ordinance Code of the County of San Josquin provides that the Board of Sugaryisors may, by resolution, designate slow areas for boating; and

WHEREAS, San Joaquin Delta Power Squadron has requested a slow area for boating on the San Joaquin River; and

WHEREAS, Resolution R-65-881 of this Board provides that the cost of installing slow area signs shall be borne by the person or persons requesting such installation; and

WHEREAS, it appears that boat speeding in the area of the San Joaquin Delta Power Squadron creates hazards to person and property:

NOW, THEREFORE, BE IT RESOLVED that a 5 mile per hour spead zone is established with signs to be placed at the entrance to the area 200 feet south of the last existing dock, with one sign to be placed at each side of the entrance. Signs should also be placed 200 feet east of the existing docks, one on the southeast tip of the berm at the south entrance and the other 200 feet east of the dock area on the north laves.

DE IT FURTHER RESOLVED that Robert J. Hamilton of the San Josequin Delta Power Equadron obtain the necessary clearance and authorization for placement of the signs from the State Lands Commission, the Exclamation Board of the State of California, the United States Army Corps of Engineers and the United States Coast Guard.

Of Title MIV of the California Administrative Code be placed by Robert J. Hamilton under the supervision of the Sheriff and the Traffic Engineer of the County of San Joaquin.
