for lease renewal. Therefore, the lessee has applied for a new grazing lease on the State's property for the continued use for cattle grazing.

- During a review of the file, the Department of Fish and Game was contacted because Fish and Game identified a portion of the area to be leased as possessing "significant" environmental values." Fish and Game stated that a number of diseases (parasites, bacteria, and viruses) that affect both domestic stock, wild deer, bighorn sheep and elk have been identified. Occasionally, circumstances suggest that domestic stock and/or wildlife may act as reservoirs for some of these disease agents which may subsequently have a negative impact on the other species. In the interest of conducting multidiciplinary and scientific studies into these diseases, animal health researchers at U.C. Davis, inconjunction with State agencies, have designed several research projects. In order to conduct this research, and with the aim of ultimately reducing, controlling or eliminating diseases shared by livestock and wildlife, Fish and Game has requested that the Commission include language into the lease document that would allow animal health researchers access to the livestock for sample taking during the course of routine round-ups, marking and/or treatment. language has been incorporated into the lease document and the lessee will cooperate, if asked by the animal health researchers, to provide access to his livestock.
- 3. The number of animals permitted on the leased lands is restricted to that which can be supported by available forage and water, reserved for necessary wildlife use. The available carrying capacity is estimated to average 370 rnimar unit months (AUM's) annually. The actual capacity may vary over the term of this lease due to climatic conditions or other natural phenomena.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that his activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land, 2 Cal. Code Regs. 2905(d)(1).
