AWARD OF THE ROYALTY OIL SALES CONTRACT STATE OIL AND GAS LEASE PRC 3242 SOUTH ELLWOOD OFFSHORE FIELD, SANTA BARBARA COUNTY, TO ENRON OIL TRADING AND TRANSPORTATION

BACKGRGUND:

At its meeting on August 22, 1990, the State Lands Commission authorized the sale of royalty oil from State oil and gas lease PRC 3242, South Ellwood Offshore Field, Santa Barbara County. The State's share of production from this lease is approximately 45,000 barrels per month of 21.4° API gravity. Chem-Oil Corporation is purchasing this oil and paying the State a bonus of \$0.5510 per barrel above a Base Price defined as the highest price posted for oil of like gravity and quality on the day of delivery in the South Ellwood Offshore Field by Mobil Oil Corporation. This contract is scheduled to expire on December 1, 1991. The oil from this lease can be taken in kind or returned to the lessee on one hundred eighty days prior written notice.

A Notice Inviting Bids for a new royalty oil sales contract to run from December 1, 1991 until October 1, 1992 was published in the <u>Santa Barbara News-Press</u> on April 1, 1991. The bid opening was scheduled for April 17, 1991. Exhibit "A" shows the results of the bidding.

STAFF RECOMMENDATION:

Fiscal and legal reviews of the submitted bid material were done by the State Lands Commission Auditing and Legal units respectively. Based on the results of these reviews, the highest responsible bidder has been identified and is designated in Exhibit "A".

Staff recommends awarding the new Royalty Oil Sales Contract for State oil and gas lease PRC 3242, South Ellwood Offshore Field, Santa Barbara County, for the period from December 1, 1991 until October 1, 1992 to the highest responsible bidder designated in Exhibit "A".
